On grant of financial up-gradation under the scheme, there shall be no change in the designation, classification or higher status. However financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, Allotment of Government accommodations shall be permitted.

If it is, come to the notice of Railway administration that the employees granted benefit under MACP scheme are not eligible to get the benefit due to any reason, the financial up-gradation granted to such employees will be withdrawn. Financial up-gradation under the MACPS shall be purely personal to the employee and shall have no relevance to his seniority position. This Office Order is subject to condition that employee is not undergoing any effective punishment under DAR, VIG, and SPE Cases etc.

The above mentioned employee is not eligible for any facilities on financial Up gradation account. This has the approval of the Competent Authority.
