

NOTIFICATION

Sub: Re-engagement of Retired staff on monthly remuneration basis in Sr. DFM BB's Office for Gati Shakti Units (GSU's).

Gati Shakti Unit of Mumbai Division has been newly formed as per Railway Board's letter dated 27.07.2022. Around 73 works have been allotted for execution to Gati Shakti Unit, Mumbai Division.

Applications from retired Sr. Section Officers having knowledge of Railway Finance and are capable to analyze various types of proposals, estimates, agreements etc. are called for to reach Sr. DFM BB, Admin Section, Mumbai CST on or before 23.06.2023. The re-engagement will be on monthly remuneration basis.

Terms and Conditions of re-engagement of retired staff

1. Scheme is valid for the period of one year from the date of engagement of the staff and further extendable as per the requirement of the administration.
2. Staff of Accounts Department retired from Railway service in Group 'C' can only apply .
3. The maximum upper age limit for the Re-engagement of staff is 65 years. No re-engaged employee should continue in service beyond 65 years of age.
4. The Administration is at liberty to terminate the services of the re-engaged employees in case their work/conduct is found unsatisfactory.
5. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for Re-engagement. Further employees retired under SRRS/LARGESS will not be eligible.
6. The remuneration for re-engaged staff fixed as **monthly** remuneration will be determined by reducing pension from his/her last pay drawn. The re-engaged employees are not entitled for any other benefit or facilities except the monthly remuneration. It will be ensured that the total monthly emoluments and pension drawn by the retired employee re-engaged on contract basis will not be more than the last pay drawn by him/her at current DA rates.
7. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
8. Re-engagement shall be subject to prescribed medical fitness.
9. Suitability/Competency of the applicant shall be adjudged by competent authority before their re-engagement.
10. The Re-engaged Retired employee will have to give 7 days Notice for discontinuing the service.
11. Re-engaged employees shall be on duty on normal duty hours followed by the office in which they will be posted. The duty hours can be changed as per the requirement of work by the administration. They will be eligible for weekly off and General Holidays observed by the office in which they will be posted. The Re-engaged employee will not be eligible for any kind of leave (like CL, RH, APL, Sick Leave etc.). For absence if any, appropriate deduction will be made from the monthly remuneration.
12. Copy of following documents should be attached with the application and it is mandatory.
 - a) Service certificate/Pensioner Identity Card
 - b) Pension Payment Order
13. The last date for submission of the application is 23.06.2023. Staff retired from Railways desirous for re-engagement, have to submit their applications in the prescribed format at Annexure 'A' and submit to Admn Section of Sr. DFM/BB's Office, Mumbai CSMT on or before 23.06.2023.
