

Sub: Application against GDCE-01/2023 dated 1/8/2023.

Notification against GDCE-01/2023 was issued by RRC on 1/8/2023 for the employees appointed on or before 1/8/2021. Last date of receipt of application was 2/09/2023. On receipt of clarification issued by Board vide letter dated 6/10/2023, application module was again opened for those employees who were appointed between 2/8/2021 and 1/8/2023. However, it has brought to the notice of this office that few employees appointed prior to 1/8/2023 could not apply due to non-availability of IPAS data provided by EDP Centre.

To avoid inconvenience to the employees who are eligible and interested to apply against the above GDCE, it has been decided to consider their application in physical mode through proper channel. Such employee should attach the proof of screen shot along with their application that his IPAS data is not available in the system. Last date of receipt of application from the employees in the Personnel Branch of the respective Division/Workshop/Unit will be 31/10/2023. Personnel Officer of the Divn./Workshop/Unit will forward the applications to this office in one lot duly verifying the service particulars of only those employees appointed till 1/8/2023. If no application is received, NIL statement be sent to this office on or before 3/11/2023.
