

'NOTIFICATION'**ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS ON CONTRACT BASIS ON SOLAPUR DIVISION, CENTRAL RAILWAY**

Applications are invited for engagement of Full Time Medical Practitioners/Doctors on Contract basis in Sub Divisional Railway Hospitals at Kurduwadi & Daund on Solapur Division, Central Railway, from open market who fulfills the eligibility criteria specified below. The fresh candidates and retired government doctors (State/Central Government) who fulfills the criteria are eligible to apply against this notification.

- 2) Specialist – Surgeon/Orthopaedician/Dermatologist/Pathologist/Ophthalmologist/Radiologist-

Monthly Remuneration:

A) For Candidates


- 1) For GDMO Doctor- Rs.75,000/-
- 2) For Specialist Doctor- Rs.95,000/- (for first year) & Rs.1,05,000/- (for second year onwards)
- 3) For Super Specialist Doctor- Rs.1,15,000/-

(B) For Retired Government Doctors.(State/Central Government)

Monthly remuneration plus pension drawn by Retired Doctors should not exceed last pay drawn.

Age Limit : As on 09.11.2023

- 1) For candidates –Not more than 53 years
- 2) For Retired Government doctors –Not more than 67 years.



**Other Terms & Conditions for Engagement of CMPs on Contract Basis :**

1. The appointment is purely on contract basis till joining of Doctors through UPSC at fixed remuneration & Full time contract, no further claim for continuation etc. will be entertained.
2. The Contract Doctors are not entitled for any other benefits like House Rent Allowance, Dearness Allowance, City Compensatory Allowance, Travel benefit etc.
3. The contract will be terminated by the Railway once the regular doctors reports back or till the requirement exists, for a maximum period of 01 year or non-performance of the contract staff with 15 days notice without assigning any reason, whichever is earlier. The contract period can be extended at the interval of 01 year at a gap of minimum 07 days, up to 12 tenures or till the vacancies are filled up, which is earlier.
4. The Contract Doctors will also be utilized for general patients.
5. It is expected that their services shall be utilized in any exigencies. Hence, a thorough knowledge about the risk involvement has to be borne in mind.
6. NOC from the current employer should be made available, if engaged and selected.
7. Private Practice will not be allowed.
8. Document verification of only selected candidates will be done at the time of joining and in case of any discrepancy, the next candidate in the waiting list will be called for joining.
9. Candidates appointed on contract with the Railways will not have any claims or right for his / her continuity in service or automatic extension of the terms on the contract. The services will be terminated at the end of the contract period or as per Administrative decision further.
10. Selected candidates will have to undergo prescribed medical examination and only fit and selected candidates/retired Doctors will get joined.
11. No communication will be entertained in this regards.

13. Decision by this Office in any matter of the process will be final and binding and no enquiry or correspondence will be entertained in this connection.
