

Sub: Special Campaign 3.0-Reducing pending matters to the minimum possible in Government.

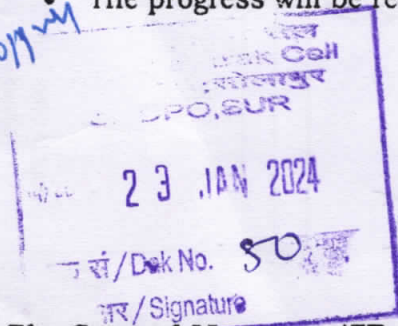
Ref: Secretary, Railway Board's D.O. letter of even number dated 11.09.2023

Kindly refer to my predecessor's DO letter referred to above conveying the decision of Board to undertake the Special Campaign 3.0 from 2nd October, 2023 to 31st October, 2023 on the entire Indian Railways under the aegis of Department of Administrative Reforms & Public Grievances (DARPG), which is the nodal Department on the subject matter, for institutionalizing Swachhata and minimizing pendency in Government offices.

2. Nodal officers were appointed at all field unit levels (ZRs, PSUs, PUs and Training Institutes) to assess & fix targets and to implement the campaign and further to furnish information to Board regarding progress made during the campaign. It is due to your untiring efforts, Ministry of Railways could achieve almost 100% targets in many parameters and successfully implement the campaign.

3. Secretary, DARPG has now communicated that as a sequel to the month long Special Campaign 3.0, the campaign has to be institutionalized and the thrust of the campaign should be maintained throughout the year. Accordingly, it has been decided that the following actions have to be taken up by Railways/Units on a regular basis in order to maintain Swachhata and keep the pendency to minimum possible:

- The system of Nodal officer in each Railway Unit, who will oversee the institutionalization/continuation of activities covered in the Special Campaign, may continue.
- All Railway Units may dedicate 3 hours every week for continuation of the activities covered in the Special Campaign across all offices.
- The Nodal Officers of each Railway Unit may review the progress of activities on a weekly basis. The data /progress report will be collected from all Nodal officers by Google Spreadsheets on monthly basis.
- The progress will be reviewed at the Board's level on a monthly basis.
