
With reference to above , examination for filling up 09 vacancies (01 UR, 04 SC,04 ST) for the post of Jr.Clerk Level –2 against 16 2/3% LDCE Quota in ministerial department in Pune Division was conducted in Pen & OMR Manner on 03/04/2024 .

Answer Key of subject examination is published hereby on website <https://cr.indianrailways.gov.in>. As per HQ's guidelines, the procedure regarding submission of representations against the Answer Key is detailed below.

- The examinees (only candidates who appeared) of the corresponding exams will be given only 7 days (including intervening holidays) from the day next to date of publishing of keys in website **i.e. from 04.04.2024 to 10.04.2024** to send a written representation with respect to keys and ambiguity in questions to respective personal branch officer on the notified email id after obtaining endorsement of their controlling branch officer certifying the identity of the examinee raising the objection. **Applications/ representations from employees other than examinees OR anyone else will not be entertained.**
- The Representation should be strictly about the **'Answer Key and ambiguity in questions of the subject exam'** only.
- **No further time will be given under any circumstances .**
- The representation should be submitted along with the documentary evidence on the basis of which the objection is raised. Any representation without such authority / evidence will not be considered.
- The final Answer Key along with " decision on the representations received regarding wrong key answers OR the decision in case of discounting any questions OR in case of incorrect wording of question/s" will be published on railnet within the period of 03 working days .
- **The decision of the Paper Setting officer will be final and no further correspondence in this regard will be entertained.**
- **Any objection regarding above examination may be send on email id confidential.punepersonnel@gmail.com .**

The procedure mentioned above should be strictly followed. This is as per Rly Board instructions vide RBE 91/2022 dt. 03/08/2022 and HQ's CR No. 130/2022 vide L.No. P/HQ/Ruling/O/803 dt. 07/10/2022.
