## ADVANCE RATE NOTIFICATION NO. 106 of 2024(GOODS)

Sub: Permissible Carrying Capacity (PCC) of BOXNHL wagon for loading of steel coils.

(C/533/GR-I/2020/0/I)

Ref: Rates Master Circular on PCC/CC+8 etc./2020/0 and corrigendum No.97 thereto.

Railway Board's letter No.TCR/1394/2020/4/Pt.1 /3467040 dated Authority: :23.08.2024 (Corrigendum No. 04 to Corrigendum No.97 to Rates Master Circular /PCC /CC+8 etc ./2020/0)

- 1. In terms of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various wagons have been notified up to one decimal place.
- 2. The same has been reviewed and the Competent Authority has decided to revise PCC of BOXNHL and BOXNHL25T wagon over different routes as 64.0 tonnes (for Steel Coils only).
- 3. Accordingly, S.No. 9 & 13 in Annexure-IA (A-Open Wagons) of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 shall be revised as under:

- 4. The above shall be effective from 27.08.2024 and shall remain in operation till further advice.
- 5. All other terms and conditions of Rates Master Circular referred above and Corrigenda thereto shall remain the same.
