The Clarification sought by FOIS/CRIS vide e-mail under reference is as under-

SN	Clarification sought	FM Dte Remarks
1.	As per the modified para in the above referred letter, empty freight will be charged at 50% of loaded freight of the highest class of the commodity during the month. However, under illustration, empty charging is calculated for 50% of the distance. Thus, whether 50% of the rate to be charged on 50% of the excess empty distance? As per extant policy, empty freight is charged at 50% of loaded freight of the highest class of the commodity during the month in the system. A clarification may be issued.	Empty freight will be charged at 50% of loaded freight of the highest class of the commodity during the month for the excess distance of empty run, and not for 50% chargeable distance, as illustrated.
2.	It is proposed that if an agreement has been registered for charging empty movement to and from examination point, then those distances shall also be considered in calculating total empty distance during the month else not, as is the extant practice. If any modification is required, it may be advised.	As per the existing policy provisions distance travelled to and from examination point is not chargeable. Hence, it should not be considered for calculating empty movement charge.

3.	It is proposed that if freight is due for empty movement (as per total loaded and empty data for the month), then the same will be charged on the first RR generated for empty movement in the next month, or any ume thereafter. Please advice, if this is acceptable	The freight is due for empty movement shall be charged on the first RR generated for empty/loaded in the next month.
4.	Since in the current month of October 2024, system has been charging excess empty distance travelled as compared to its previous loaded movement, the same shall be continued till the end of this month.	agreed
5	November 2024 onward, the existing business logic shall be stopped, and no excess empty distance charge will be levied for each excess empty movement after a loaded movement in the month of November 2024.	agreed
6	First empty movement RR of next month i.e. December 2024, will be charged with due empty movement freight for November 2024.	agreed
