ADVANCE RATE NOTIFICATION NO.135 of 2024 (GOODS)

Sub: Running of freight trains on CC+8 tonne routes. (No. C/533/GR-I/2020/0/I)

Ref: (i) Board's letter No. 2018/E&R/1(8)/4 dated 24.04.2018.

(ii) Rates Master Circular/PCC/CC+8 etc./2020/0 dated 01.05.2020.

Authority: Railway Board's letter No. TCR/1394/2024/CC+8/3467808 dated: 05.11.2024 (Corrigendum No. 119 to Rates Master Circular/PCC/CC+8 etc./2020/0)

1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.

2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.

3. Northern Railway has forwarded proposal with due approval of General Manager to include the following route of Northern Railway in the list of already identified CC+8 routes:-

Jalandhar City Jn.(JUC) - Nakodar Jn.(NRO)

- 4. Sanction of the Competent Authority is hereby accorded to include the above referred route of Northern Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 50 kmph. This speed limit can be reviewed by the Zonal Railway and may be revised as and when required.
- 5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified
- 6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

7. These instructions shall come into effect from 09.11.2024 and shall remain valid till further advice.

8. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
