Sub: Routes of running of 25 Tonne Axle load wagons.

1. In terms of reference at (i) & (ii) above, Board's approval was communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit/certified for 25 Tonne axle load on various notified routes.
2. The routes are notified in terms of Annexure-IV of reference (iii) above.
3. Matter has been examined, in the light of South Eastern Railway's proposal, the Competent Authority has approved to add following routes, subject to operation of 25 ton axle load at 45kmph in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified routes:

Bhojudih Jn.(BJE)-Bhaga(VAA)-Mahuda Jn.(MHQ)-NSC Bose J GOMO(GMO) (Excluding)

4. This speed restrictions imposed from time to time can be reviewed by Zonal Railway and may be revised as and when required.
5. Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.
6. Fulfillment of all pre-requisites and installation of WILD as planned within one year as stipulated in Board's letter No. 2019/CE-II/TS/25t dated 01.09.2020 and No. 2019/CE-II/TS/25t dated 23.07.2024.
6. These instructions shall come into effect from 30.11.2024 and shall remain valid till further advice.
7. This issues in consultation with Traffic Transportation,Civil Engineering Directorate and with the concurrence of the Finance Directorate of Ministry of Railways.
