ADVANCE RATE NOTIFICATION NO. 150 of 2024(GOODS)

Sub: Permissible Carrying Capacity (PCC) of BOXNHL wagon for loading of steel coils.

(C/533/GR-I/2020/0/I)

Ref: Rates Master Circular on PCC/CC+8 etc./2020/0 and corrigendum No.97 thereto and corrigendum No.04 to corrigendum No 97.

Authority: Railway Board's letter No.TCR/1394/2020/4/Pt.1 /3467040 dated :20.12.2024 (Corrigendum No. 05 to Corrigendum No.97 to Rates Master Circular /PCC /CC+8 etc./2020/0)

1. In terms of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various wagons have been notified up to one decimal place.

2. Further, in terms of corrigendum No.04 to Corrigendum No.97, PCC of BOXNHL and BOXNHL25T wagons over different routes have been notified as 64 tonnes for loading of Steel Coils only.

3. The above has been reviewed and the Competent Authority has decided to revise PCC of BOXNHL and BOXNHL25T wagon over different routes as 56 tonnes or actual weight, whichever is higher, subject to maximum of 64.0 tonnes for Steel Coils only.

4. Accordingly, S.No. 9 & 13 in Annexure-IA (A-Open Wagons) on Page 4 of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 shall be revised as under:

(a) For Commodities under Main Commodity Head Minerals and Ores, Bricks & Stones, Cement, Coal & Coke;

(b) All types of Slag under Main Commodity Head Metal Scrap & Pig Iron;

(c) Red Mud under Main Commodity Head Clay and Sand;

(d) Only DAP and NPK/SNPK fertilizers, Rock Phosphate (in both Bag & Loose conditions) under Main Commodity Head Chemical Manures.

** For commodities other than those mentioned above.

*** 56 tonnes or actual weight whichever is higher subject to maximum of 64 tonnes for steel coils only.

Note: Steel coils include Hot Rolled Coils, Cold Rolled Coils, Galvanized Coils, Stainless steel in Coil as mentioned in the General Classification of Goods Tariff.

5. For loading in above wagons, overriding priority shall be given to the high yielding commodities over steel coils at reduced PCC at the same terminals.

- 6. The above shall be effective from 24.12.2024 and shall remain in operation till further advice.
- 7. All other terms and conditions of Rates Master Circular referred above and Corrigenda thereto shall remain the same.
- 8. This issues in consultation with Traffic Transportation, Mechanical (Freight) and with the concurrence of Finance Directorate of the Ministry of Railways.
