Sub: Routes of running of 25 Tonne Axle load wagons. (C/533/GR-I/2020/0/I)

- 1. In terms of reference at (i) & (ii) above, Board's approval was communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit/ certified for 25 Tonne axle load on various notified routes.
- 2. The routes are notified in terms of Annexure-IV of reference (iii) above.
- 3. Matter has been examined, in the light of South Eastern Railway's proposal, the Competent Authority has approved to add following routes in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified routes:
 - Birmitrapur(BRMP)- Panposh(PPO)
 - Adra(ADRA)- Rukni(RUI)
- 4. Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.
- 5. The inclusion of the above referred routes in the list of already indentified 25 Tonne axle load routes shall be subject to maximum permissible speed of 45 kmph. This limit shall be reviewed by the Zonal Railway and may be revised as and when required.
- 6. These instructions shall come into effect from 28.11.2024 and shall remain valid till further advice.
- 7. This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of Ministry of Railways. Staff concerned to please note and act accordingly.
