### CORRIGENDUM NO. 1 TO SPECIAL FREIGHT TRAIN OPERATOR (SFTO) SCHEME

1. Attention is invited to Para 4.0 of Freight Marketing Master Circular/SFTO/2014/0 issued vide Board's letter No. 2014/TC(FM)/4/23 dt. 22.12.2014, wherein commodities covered under the scheme have been listed. It has been decided to include LPG as a commodity in sub-para(b) of para 4 under category 2 of Special Freight Train Operator (SFTO) Scheme.
2. Accordingly, sub-para (b) of Para 4 under category 2 is modified as under :
  - (b) Petrochemicals that includes Light Diesel Oil (LDO), Carbon Black Feed Stock (CBFS), Low Sulphur Heavy Stock (LSHS), Heavy Petroleum Stock (HPS), Vacuum Gas Oil (VGO), Low Viscous Furnace Oil (LVFO), Low Sulphur Furnace Oil (LSFO), Residue Crude Oil (RCO) and Liquified Petroleum Gas (LPG) (excluding Petroleum products like Naphtha, Aviation Turbine Fuel, High Speed Diesel, Kerosene Oil, Petrol, Furnace Oil).
3. This issue with concurrence of Finance Directorate of the Ministry of Railways.
4. These instructions will come into force with immediate effect.
