Attention is invited to Railway Board letter under reference, wherein at Para 5.1 it was notified that Ores, Minerals, Coal and Coke will be the Restricted Commodities for movement by Containers.

The issue of permitting movement of some of the restricted commodities whose movement by IR General Service Wagons is miniscule has been examined in Railway Board and approval of Railway Board is hereby communicated for permitting movement of "Quick Lime" in Containers for One year on experimental basis under FAK rates.

The above permission comes into force with effect from 01.03.2017 and will be valid till 28.02.2018. Zonal Railways shall closely watch the movement of "Quick Lime" from their Railways to ascertain incremental quantity and earnings from movement of "Quick Lime" and furnish a monthly report on the same.

FOIS/CRIS may capture the loading of Quick lime in container trains under separate code issued by Railway Board vide letter No. 2013/Stat.V/83/2/Code Pt. 1 dated 14.02.2017 for analysis in the future.

This issues with the approval of Traffic Commercial and concurrence of Finance Directorate of Railway Board.
