ADVANCE RATE NOTIFICATION NO. 09 of 2017 (Parcel/Coaching)

Sub : Amendment to policy for Parcel Cargo Express Train to Private Operators.

(No. C/562/GT/Leasing PCET/Pt.I)

Ref : 1. Board's letter No. 2007/TC(FM)/10/3 dt. 20.02.2007 (FM Circular 02 of 2007).

2. Board's letter No. 2013/TC(FM)/10/11 dt. 15.06.2016 (FM Circular 04 of 2016/ARN No. 06 of 2016 (Parcel/Cog)

Authority : Railway Board's letter No. 2016/TC(FM)/10/17 dt. 05.05.2017 (FM Circular 07 of 2017).

Extract of Boards circular under authority is reproduced below :

1. The policy for 'Parcel Cargo-Express Train' to private operators was issued under Freight Marketing Circular No. 02 of 2007 vide Board's letter No. 2007/TC(FM)/10/3 dated 20.02.2007.
2. Based on the reference/recommendation from NF Railway, in order to liberalize the policy of PCET the following provisions have been amended:
3. Para 1.0 of the FM Circular No. 2 of 2007 may be read as follows:
1.0 The service will be provided on end-to-end basis on round trip basis only.
4. Para 2.1 and 2.2 may be treated as deleted and a new para numbers as 2.1 may be read as follows:
2.1 Reserve price for round trip:

Applicable for	Reserve Price
For all origin-destinations (round trip)	1.25 times of single journey freight at Scale - P

5. Para 2.7 which was added vide FM Circular No. 04 of 2016 may be read as:
However, zonal railway may with finance concurrence and approval of CCM, revise the reserve price where considered necessary downwardly to maximize the utilization of the parcel spaces. However, the reserve price shall not be below the Scale 'P'.
6. These instructions will come into force with immediate effect and shall be made applicable to all future tenders to be invited for leasing out of PCET. Further:
 - i. The cases, where tenders have been finalized and 'Letter of Allotment (LOA)' has been issued to the party by the Railway Administration prior to issuance of this circular, the leaseholder shall be allowed to operate the leasing contract as per policy guidelines prevailing at that time.

- ii. These cases where originating or destination is of NFR, where 'Letter of Allotment (LOA)' for award of leasing contract has not been issued to the party before issuance of this circular, the Zonal Railways will cancel all such tenders and return the earnest money to the tenderers.
7. Zonal Railways are requested to go through these policy guidelines carefully and follow the same therein strictly.
8. Zonal Railways, before executing agreements for PCET leasing contracts, must ensure that necessary changes have been made in the agreement in accordance with this modified policy.
