ADVANCE RATES NOTIFICATION No. 33 OF 2017 (Cog)

Sub:- 'URS-E-Shareef of Hazarth Khwaja BandeNawaz' at Gulbarga-2017.

Please note that the Mela Surcharge on all tickets to/from Gulbarga station in connection with Urs-e-Shareef of Hazarth Khwaja Bande Nawaz during the period from 08/08/2017 to 12/08/2017 with the principal day being on 08/09-08-2017 will be levied at the following rates.

Second Class (Ord./Mail/Exp.)	5.00	5.00
Sleeper Class (Ord./Mail/Exp.)	5.00	10.00
AC Chair Car & AC 3-tier	10.00	20.00
First Class (Ord./Mail/Exp.) & 2AC Class	15.00	30.00
AC First Class	20.00	40.00

Further it is clarified that the Mela Surcharge should be levied only in respect of outward tickets issued from Mela Station and on return tickets to the Mela Station and back. This surcharge will not be levied on single journey ticket from various stations on the Indian Railways to the Mela station.

The Mela surcharge is leviable in respect of single journey tickets costing more than Rs. 15/- basic fare.

The accountal of tickets issued during the mela period should be shown separately below the regular series giving necessary remarks against the same in passenger classification. The accountal of surcharge collected during the above period should be shown separately in the classification showing the number of tickets sold.

All other terms & conditions regarding levy of Mela Surcharge will remains the same. Necessary instructions may be issued to all staff concerned immediately.
