**Sub:- Mela Surcharge during Kartik Purnima Mela at Sonpur & Hajipur from 02.11.2017 to 03.12.2017.**

**Ref:-** Sr.DCM/ECR/SEE's letter no. C/514 /K.P. Mela/Sonpur/17 Dtd. 19.09.2017.

Kartik Purnima Mela at Sonpur & Hajipur is going to be held from 02.11.2017 and will continue upto 03.12.2017. Since huge numbers of Passengers/Pilgrims are expected to visit Sonpur and Hajipur during this period, additional amenities are required to be arranged at Sonpur and Hajipur. As such Mela Surcharge at these stations should be collected as per prescribed rate as under:-

Sl.No.	Class	Rate
1.	Second Class (Ordinary / Mail/Exp.)	Rs. 5/- (Rs. Five only)
2.	Sleeper Class (Ordinary / Mail/Exp.)	Rs. 10/- (Rs. Ten only)
3.	A.C. Chair Car & A.C. 3-Tier	Rs. 20/- (Rs. Twenty only)
4.	First Class (Ordinary/M/E) & A.C. 2-Tier	Rs. 30/- (Rs. Thirty only)
5.	A.C. 1 <sup>st</sup> Class	Rs. 40 /- (Rs. Forty only)

Mela surcharge should be levied in respect of tickets issued from Mela station (i.e. SEE & HJP) and also on return tickets to the Mela station and back. This surcharge should not be levied on single journey tickets from various stations on the Indian Railways to the Mela station. Surcharge as indicated above will be levied only in respect of ticket costing more than Rs. 15/- (Fifteen) (Basic Fare) and will not be levied on tickets costing upto Rs. 15/- (Fifteen) (Basic Fare).

Necessary instructions may be issued to all concerned including PRS centers immediately.
