Mela Surcharge at this station should be collected as per prescribed rate as under:-

Class	Revised (Rs.)
Second Class (Ord./Mail/Exp.)	5.00
Sleeper Class (Ord./Mail/Exp.)	10.00
AC Chair Car & AC 3-tier	20.00
First Class (Ord./Mail/Exp.) & 2AC Class	30.00
AC First Class	40.00

Further it is clarified that the Mela Surcharge should be levied only in respect of outward tickets issued from Mela Station and on return tickets to the Mela Station and back. This surcharge will not be levied on single journey ticket from various stations on the Indian Railways to the Mela station.

The Mela surcharge is leviable in respect of single journey tickets costing more than Rs. 15/- basic fare.

Please circulate the instructions to all concerned staff and ensure strict compliance.
