Sub: Mela Surcharge for Mahamasthakabhisheka at Sharvanabelagola and Hassan.

The Mahamasthakabhisheka of the Gommateshwara (Babubali) at Sharvanabelagola will be held from 07.02.2018 to 26.02.2018.

Sharvanabelagola (SBGA) and Hassan (HAS) Railway Stations are identified as Mela Stations for levy of Mela Surcharge from 07.02.2018 to 26.02.2018. The rate of levy of Mela Surcharge is as under:

S.No.	Class	Rate (In Rs.)
01	Second Class (Ody. & M/E)	5
02	Sleeper Class (Ody. & M/E)	10
03	AC Chair Car/AC 3T	20
04	First Class (Ody. & M/E)/AC 2T	30
05	First AC Class	40

Mela Surcharge will be levied in respect of following type of tickets:

- Outward tickets issued from Mela Station.
- Return tickets to Mela station and back.
- Mela Surcharge will be levied in respect of tickets costing more than Rs.15/- (basic fare). This surcharge will not be levied on tickets costing upto Rs.15/- (basic fare)
- This surcharge will not be levied on single journey tickets issued from various stations on Indian Railways to Mela Stations.

All other terms and conditions regarding levy of Mela Surcharge will remain the same.

Necessary instruction may be issued to all staff concerned immediately.
