Sub: Closure of halt stations - Laul, Taklimiya and Sanvatsar.
Ref: CCM(PM)/CSTM's letter no. C/RC/Closure dated 10/11/2017.

In the above mentioned letter it was conveyed that competent authority has accorded sanction to the proposal for closure of Laul, Taklimiya, Sanvatsar halt stations. Laul station is situated on branch line PVR-MRJ section and Taklimiya, Sanvatsar stations are situated on main line of DD-MMR section. These stations are being closed due to daily average number of passengers below the stipulated average number of passengers (25 per day on branch line and less than 50 per day on main line).

Further it was requested to advice the date of closing of halt station to issue notification for closure of halt station for passenger traffic. **Therefore it is suggested that these stations may be closed from 1st December 2017.**
