Reference COO, Jagriti Sewa Sansthan letter dated August, 2017 (.) **Ministry of Railways have, as a special case, decided to grant 25% concession in the basic fares in second and sleeper classes only** for the special train on FTR booked by Jagriti Sewa Sansthan ex. Mumbai on 25.12.2017 and return to Mumbai on 08.01.2018 via Dharwad, Whitefield, Madurai Jn, Tada, Gopalapatnam, Visakhapatnam, Brahmapur, Rajgir, Deoria Sadar, Gorakhpur Jn, Delhi-Safdarjang, Tilonia, Ajmer Jn, Kalol, Gandhi Nagar (.) Point to point charges should be calculated for every break points and also all other charges for the booking of special trains on Full Tariff Rates should be taken in full (.) Earnings/emoluments of the travelling persons should not be more than Rs. 5000/- per month and travelling expenses are not borne by the Central or State Government, or by any local authority or statutory body or a Corporation or a Government undertaking or a University (.) Necessary instructions may be issued to the staff concerned immediately (.) This issues with the concurrence of the Finance(Commercial) Directorate of the Ministry of Railways (.)
