As per sub-rule 138(2) of notification 27/2017 (further amended vide CBEC notification 3/2018), "Provided that where the goods are transported by railways or by air or vessel, the e-way bill shall be generated by the registered person, being the supplier or the recipient, who shall furnish, on the common portal, the-

- a. information in Part B of FORM GST EWB-01; and
- b. the serial number and date of the Railway Receipt or the Air Consignment Note or Bill of Lading, as the case may be".


The responsibility to generate E-way Bill online as per the extant rules shall thus rest with the registered person as supplier or recipient; i.e. as consignor or consignee.

Board has made a representation to CBEC seeking certain modifications in the other extant E-Way Bill Rules. Till such time that a decision in this regard is received from Ministry of Finance (CEC), the following guidelines may be adhered to:

- a) Board has decided that an undertaking shall be obtained from each consignor on the Forwarding Note before accepting goods for Loading/Transportation as per Annexure A. Zonal Railway shall take necessary action to ensure the same in case of manual Forwarding Notes also. CRIS may modify the Forwarding Note format suitably in the system in case of online demand registration.
- b) The consignor/Consignee shall generate the E-way using the FNR number as Transport Document Number, instead of RR number. Consignor shall provide the E-way bill number to goods clerk, who shall enter the same in records. Detail procedure is as given in Annexure B.

These guidelines shall come into force w.e.f. 01.02.2018 and shall remain in force till further advice.

All concerned may be advised accordingly.

Process of generation of FNR Number, to be provided to Consignor/Consignee, to enable generation of E-Way Bill Number by them.

A. Indents to be registered from midnight of 31.01.2018/01.02.2018:

1. The existing FNR which is printed on the RR and can be utilized for Track and Trace and identification of specific consignment, will get generated at the time of registration of Indents (for each individual Forwarding Note) at the station or through e-Demand registration by the customer.
2. This FNR Number will be visible on the FOIS Website which can be noted by the Goods Clerk. This generated FNR Number is to be conveyed to the Indenting Party (Customer) for further generation of E-Way Bill on the GST Portal.
3. For e-Demand Customers, the FNR Number thus generated shall be made available to the Customer on their Confirmation Slip (Confirming the registration of Indents) which is presently getting generated and provided to the Customer through their registered e-mail ID.
4. Customer (Consignor/Consignee) shall generate the E-Way Bill on the GST Portal feeding the FNR Number in the place of Transport Document Number.
5. Customer shall provide the E-way Bill number to Goods clerk before RR generation. Goods clerk shall enter the same in his records.

B. Indents already registered before midnight of 31.01.2018/01.02.2018:

1. The existing FNR which is printed on the RR and can be utilized for Track and Trace and identification of specific consignment, will get generated at the time of first wagon release against the Forwarding Note in FOIS/TMS Application by the Goods Clerk.
2. This FNR Number will be visible on the FOIS Website which can be noted by the Goods Clerk. This generated FNR Number is to be conveyed to the Indenting Party (Customer) for further generation of E-Way Bill on the GST Portal.
3. Customer (Consignor/Consignee) shall generate the E-Way Bill on the GST Portal feeding the FNR Number in the place of Transport Document Number.
4. Customer shall provide the E-way Bill number to Goods clerk before RR generation. Goods clerk shall enter the same in his records.
