


No. TCII/2010/2002/IRT (.) Ministry of Railways have agreed as a special case, to grant 50% concession in Second/Sleeper class in the basic fares of Mail/Express trains to the students of the Institute of Rail Transport, New Delhi attending the **Contact Classes** to be organized by the above Institute at Mumbai, Kolkata, Delhi, Chennai, Secunderabad, Bhubaneshwar, Guwahati & Lucknow centers subject to the conditions that concession will be admissible to students upto the age of: (i) 25 years in case of students belonging to General category and (ii) 27 years in case of students belonging to SC/ST category (.) The concession will not be admissible to such students who are under full time employment (.) Dates of contact classes will be intimated by Institute of Rail Transport, New Delhi direct to Railway Administrations concerned (.) Students will submit the certificate issued by Executive Director/Manager/Registrar of Institute of Rail Transport, New Delhi to the office of the CCM, DCM, Traffic Supdt., Area Officer, etc., who will issue concession order on presentation of which the Station Manager will grant concession (.) This concession will remain valid upto **30.06.2018** (.) This concession has been granted as a very special case and should not be quoted as precedent in future (.) This issues with the concurrence of the Finance Directorate of the Ministry of Railways (.) Necessary instructions may be issued to staff concerned immediately (.) Matter most urgent (.)
