

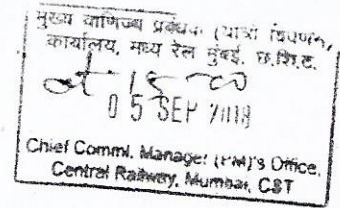

**Sub: Modification in the Jan Sadharan Ticket Booking Sewak (JTBS) and Yatri Ticket Suvidha Kendra (YTSK) policies.**

The YTSK and JTBS schemes have been revised and instructions delineating the modifications have been issued vide Commercial Circulars no. 41 of 2018 and 42 of 2018 respectively.

1.1 Most of the changes spelt out vide letters referred to above require modification in software by CRIS. CRIS may, therefore, carry out the requisite changes in keeping with the date of effect of the modified policy provision indicated in the CCs no. 41 of 2018 and 42 of 2018.

2. Further, attention is drawn towards reduction in time limit up to which YTSKs are debarred to book reserved tickets on the opening day of reservation, from 30 minutes of opening to 15 minutes both in case of general as well as Tatkal reservation (indicated in CC no. 42 of 2018).

2.1 It has been decided that the restriction of 15 minutes should be uniformly applicable to all authorized reserved ticketing agents of Indian Railways including e-ticketing agents as well as YTSKs.

3. Necessary action may, therefore, be taken accordingly under intimation to all Zonal Railways as well as this office.
