Those who have received GP 4200 under MACP will not be considered in this regard.

3. Selection Procedure : Selection to the post of OS will comprise of viva-voce test only .
4. General Conditions:-

 - 2) The applicant should apply as per proforma enclosed.

- 5) The selected candidates may be repatriated to parent department at any time, if it becomes necessary for the administration, without assigning any reason.
- 6) Once selected, applicants will not be permitted to withdraw and refuse posting in Vigilance Department.
- 7) The staff should have clear Vigilance history.
- 8) The date of viva-voce / screening/ suitability test shall be intimated to the eligible candidates later.

Original service register and attested Xerox copies of APAR's/ Working Reports for the years 2017-18, 2016-17, 2015-16 of the candidates should be sent to this office, for selection. .

It must be certified whether any DAR/SPE cases are pending/contemplated against the employee.
