

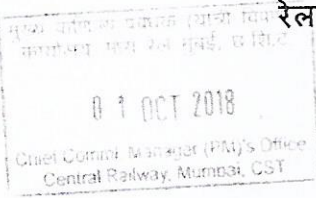

No. 18 (2) of Annexure to rule 101 of IRCA Coaching Tariff No. 26, Part I (Vol. II) in Second/Sleeper class to persons with earnings/emoluments of not more than ₹5000/- per month attending the 'Tri-annual conference' of Kreedha Bharati at Dhanbad, Jharkhand from 28<sup>th</sup> to 30<sup>th</sup> December, 2018. (.) This concession has been granted as a very special case and should not be quoted as a precedent (.) This concession is admissible only in normal train services and not for booking of Special Trains/Coaches (.) The concessional return journey tickets may be issued on payment of one single journey Second/Sleeper class Mail/Express basic fares, (however, supplementary charges like reservation charge, superfast charge etc should be levied separately for both direction) to persons travelling more than 300 Kms. from journey commencing station to the station serving the place of Conference i.e. Dhanbad on production of the requisite certificate from the Organiser, Kreedha Bharati, Pune, Maharashtra. (.) Necessary instructions may be issued to the staff concerned immediately (.) This issues with the concurrence of Finance Directorate of this Ministry (.) Matter most urgent (.)
