Ref: (i) Commercial Circular No.18 of 2011 dated 13.05.2011
(ii) Commercial Circular No. of 52, of 2016 dated 29.06.2016

As per S.No.38 of IRCA Coaching Tariff No. 26 Part-I (Vol.II) concession is admissible to Men Senior Citizens of the age of 60 years and above and 58 years & above in case for Women Senior citizens of Indian Nationality. The element of concession is 40% for Men Senior Citizens and 50% for Women Senior Citizens.

- As an interim measure till finalization of uniform policy by Ministry of Law & Justice, it has now been decided to grant of 40% concession in passenger fare to Transgender (T) Senior Citizens of the age of 60 years and above.
- This will be implemented with effect from 01.01.2019.
- Other terms and conditions shall remain the same.
- CRIS & IRCTC may make necessary changes in the software.
- Necessary instructions shall be issued to the all concerned.
- This issues with the concurrence of Finance Directorate of the Ministry of Railways.
