**OFFICE ORDER No. 16/2019**

Sub- Promotion in f/o Shri. Manjee Kumar Singh, Sr.ALP/ DD as LP(G) in Level-6/GP.4200/- on completion of punishment imposed under DAR

As per DME/SUR's (Revisionary authority)/SUR's above referred letter dt. 12.12.2018 ,he punishment imposed in f/o Shri. Manjee Kumar Singh, Sr.ALP/ DD by Revisionary authority has been reduced from two years to one year on revision appeal.

As The junior Sr.ALPs to Shri. Manjee Kumar Singh, Sr.ALP/ DD has been promoted as LP(G) in Level-6/GP.4200 & Shri. Manjee Kumar Singh, Sr.ALP/ DD has been delared pass in PPC he is to be promoted as LP(G) .

In terms of Rly. Bd.'s Lr. No. E (NG) I-2008/PM/15 dt.03-09-2009, 07.06.2010 and 23.05.2012, 15.01.13 & 24.05.2013 & 03.01.2014& 16.06.2014, 09.02.2016, the following Promotion/Transfer order in LP (G) Category are issued herewith for immediate implementation.

**In terms of Rly Board's letter No 2004/ M(L)/466/7101 dt.31.08.2009, the procedure laid down regarding standardized system for Loco handling training to the ALP/Shunters before promotion as Loco Pilot Goods should be adhered to ALP/Shunters promoted as LP (Gds) should be kept under supervision of CLIs.**

**Special Note-** Promoted Loco Pilot (Goods) may require to work as LPS due to large vacancies in LPS cadre.

Fixation of Pay will be done as per extant rules on the subject. Employee is eligible to exercise an option within a period of a month for fixation of pay on promotion in the manner as laid down in RBE No. 79/2017 dt. 31/07/2017.


The above promotion order is provisional and subject to the conditions that there is no DAR/SPE/Viz case pending or contemplated or proposed to be initiated. The above promotions are subject to result of Supreme Court/ High Court/ CAT decisions.

The promotion is also subject to disposal of writ petitions / appeals / applications pending in various courts as the case may be in occupation before carrying out the transfer/ promotion order.

All the promotions shall be subject to outcome of the main SLPs & contempt petition mentioned in the Railway Board's Lr. No. 2016-F(SCT)1125/8 dt.30/09/2016 (RBE No.117/2016) & as per instructions of HQ Lr. No. P/HQ/Ruling /O/817 dt. 04.10.2016 & clarification of HQ's Lr. No. P/CR/HQ/RP/601- Policy dt. 15/03/2017.
