Shri.S B Bere Scale Porter / SUR was declared qualified for the post of Jr TE Level 3 (GP-2000) against 33.33% Dept quota from Gr.'D' to Gr.'C' in Comml.Dept on best among failed policy was directed for Initial training Course for Ticket Collector (RRB+Dept) Code No.ICTC-0465 commencing from 01/08/2018, to 01/09/2018. He was declared failed vide ZRTI/BSL memo No. Initial Ticket Collector/R/ICTC0465 dt.12/10/2018. In terms of para (c) of RB's letter No. E(MPP)2000/3/10 dt.10/08/2000(p-401) since belonging to SC category he was given 2nd chance and sent for training in course code ICTC-0467 commencing from 19/12/2018 to 18/01/2019. He has successfully completed training and declared pass vide ZRTI/BSL Memo No. Initial Ticket Collector/R/ICTC0467 dt.19/01/2019. Now he has promoted on Adhoc basis and posted as Ticket Examiner in Level 3(GP 2000).

However it is advised that those who have already awarded higher Grade Pay under MACP scheme are not entitled for pay fixation on their regular promotion as higher grade pay granted under MACP in reference to para 4 of annexure of Railway Board's letter No.PC-5/2009/ACP/2 dated 10.06.2009
