In continuation of above Commercial Circulars, Ministry of Railways have further decided that the currency of introductory offer for fare of AC EMU/DEMU service shall continue for another four months.

2. Accordingly, the base fare of single journey of AC EMU/DEMU shall be charged 1.2 times of the base fare of existing single journey tickets for First class tickets.
3. These instructions shall be valid upto 24.04.2019.
4. There shall be no change in other terms and conditions.
5. CRIS is requested to make necessary changes in the software.
