Consequent upon selection and completion of Training qualified vide ZRTI/BSL memo No. Comml.Appt.Deptt.staff 10% Quota (1st phase)/R/ICDF0017 dt.24/12/2018 and memo No.Comml.Appt.Deptt.staff 10% Quota(II nd phase)/R/ICDS0017 dated 18/01/2019 for the post of Comml.Inspector against 10%LDCE quota. Level 6 (GP-4200) following employees are here by regularised with immediate effect in terms of RB's letter No.PC-V/2016/PS/1(Stipend) dt.11/09/2018 (RBE 133/2018) and HQ office letter No.P/CR/HQ/EC/210/Comml & Traffic Apprentice dt.19/10/2018. ***Shri Niranjan Mahendra More (SC) GS/PVR, who has been selected under best amongst the fail promoted on adhoc basis for six months, during these six months period he will be given all facilities to improve his knowledge and come up to the requisite standard. At the end of six months period a decision has to be taken by the competent authority for inclusion of his name in the final panel or otherwise.**

Employees promoted are eligible to exercise the option for fixation of pay within one month. However it is advised that those who have already awarded GP 4200 under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade pay granted under MACP in reference to para 4 of annexure of Railway Board's letter No.PC-5/2009/ACP/2 dated 10.06.2009 and those who have already promoted and drawing GP 4200/-are not eligible for fixation of pay. The changes effected should be intimated to all concerned immediately. Sr No 01 is eligible for all facilities on transfer account.

All promotions shall be subject to outcome of the main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)1125/8 dated 30/09/2016 (RBE No.117/2016) and as per instructions of HQ letter No.P/HQ/ Rulinf/O/817 dt.04/10/2016 and clarification of HQ's letter No.P/CR/HQ/RP/601-Policy dt.15/03/2017. In terms of Railway Boards letter No.2018-E(SCT)1/25/9 dt.19/06/2018 circulated by CPO/CSMT vide letter No.P/HQ/Ruling/O/817 dt.21/06/2018.
