Sr. No. 03 & 05 after completion of one year Apprenticeship they are declared pass in final examination, suitability was conducted on 31/01/2019 & 12/02/2019 by Competent Authority is hereby regularized and posted against existing vacancy with immediate effect. They will be governed by New Pension Scheme w.e.f. - 01/01/2004.

Sr. No.04 after completion of 08 months Intermediate Apprenticeship he is declared pass in final examination, suitability was conducted on 12/02/2019 by Competent Authority is hereby promoted against 20% LDCE quota and posted against existing vacancy with immediate effect and he is eligible for all facilities on account of transfer.

The above Sr. No.01 to 03 and 05 are not eligible for any facilities on account of transfer.


Fixation of pay will be done as per extant rules on the subject. Employee is eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's Lr. No.E/E/1089/FR-1/1 dt.12/12/1991- Amendment to the IREC Vol.II(VI Edition 87). However those who have already awarded Higher grade under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade granted under MACP in reference to para 4 of annexure of Railway Board's letter no.PC-52006/ACPR/2 dated 10.06.2009.

Transfer of a Railway servant, ordered as a result of his promotion should be carried out by the employee as early as possible in his own interest. In the case of an employee who neither gives the refusal in writing nor joins duty on being promoted, it should be treated as refusal of promotion and action taken accordingly. It is responsibility of controlling supervisor to inform the concerned staff accordingly and get it noted. Changes took place should be intimated to all concerned.

The above promotions are subject to the condition that there is no DAR/SPE/IG. Cases pending or contemplated or proposed to be initiated. The above promotions are subject to result of Supreme Court/High Court/CAT decisions.

All promotions shall be subject to outcome of the main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)1125/8 dated 30/09/2018 (RBE No.117/2018) And as per instructions of HQ letter No.P/HQ/ Rulin/O/817 dt.04/10/2018 and clarification of HQ's letter No.PICR/HQ/FR/501-Policy dt.15/03/2017.
