
Vide Railway Board's Commercial Circulars under reference above, 0.5% discount was given **on total applicable fare** on Season Tickets (Monthly, Quarterly, Half Yearly and Yearly) over suburban section when the payment is made through digital means i.e through debit cards, credit cards, etc. These instructions are applicable up to 30.09.2019.

2. The matter has been reviewed and Ministry of Railways have now decided that the status quo may be maintained further for a period of another six months i.e. up to 31.03.2020 or any change whichever is earlier.

3. CRIS and IRCTC shall ensure necessary changes in the software and arrangements for the above.


