However those who have already awarded higher grade under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade granted under MACP in reference to Para 4 of Annexure of Railway Board's letter No.PC-5/2009/ACP/2 dated 10.06.2009. Option once exercised shall be final.


If any of above staff is under effective punishment under DAR the concern staff should not be promoted and informed this Office immediately.

In terms of Para 03 of CPO/CSTM's letter No. P / CR / HQ / RP/601-Policy dated 15.03.2017, staff promoted against UR quota and will be set off against SC/ST quota in future.
