
Sr.No. 02 & 03 are eligible for all facility on transfer account.

**They will work with Ch.S&WI(HQ)SUR and will learn the working of S&WI for 02 months in various section. Final posting will be done after this training.**

The above promotion order is provisional and subject to the conditions, that there are no DAR/SPE/Vig cases pending and not undergoing any penalty debarring promotion which should be ensured by the supervisor/official concerned before the promotion is effected. The promotion is also subject to disposal of writ petitions / appeals / applications pending in Honorable Supreme Court / High Court or CAT as the case may be. The employees are eligible to draw higher rate of pay in the promoted grade from the date they shoulder higher responsibility. Fixation of pay will be done as per extant rules on the subject. Employee is eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RBE NO. 79/2017PC-VII No. 25 File. PC-VII/2016/1/6/2 dtd. 31.07.2017.

The Date of shouldering higher responsibilities of the employee should be advised to all concerned without fail.
