



Sr. No.01 to 11 are repatriated and posted to their original post as Loco Pilot, they were more than 90 days away from foot plate duty. Therefore before taking them on foot plate duty as Loco Pilot, they have to undergo and pass the requisite refresher course and also medical examination in A-one class.

Sr. No. 12 to 20 are eligible for payment of allowance in lieu of Kilometerage, 120 K.M. per day at the rate applicable to them even if posted at HQrs, such staff would not be eligible to claim TA/DA & special pay.

The tenure of such running staff drafted to perform the duties of Crew / Power Controller will be three years with a cooling off period of equal duration. The date of effect of changes should be intimated to this office.
