Employees promoted are eligible to exercise the option for fixation of pay within one month. However it is advised that those who have already awarded Level 7 (GP 4600) under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade pay granted under MACP in reference to para 4 of annexure of Railway Board's letter No.PC-5/2009/ACP/2 dated 10.06.2009 and those who have already promoted and drawing Level 7(GP 4600).are not eligible for fixation of pay. The changes effected should be intimated to all concerned immediately. All promotions shall be subject to outcome of the main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)1125/8 dated 30/09/2016 (RBE No.117/2016) and as per instructions of HQ letter No.P/HQ/ Rulinf/O/817 dt.04/10/2016 and clarification of HQ's letter No.P/CR/HQ/RP/601-Policy dt.15/03/2017. In terms of Railway Boards letter No.2018-E(SCT)/125/9 dt.19/06/2018 circulated by CPO/CSMT vide letter No.P/HQ/Ruling/O/817 dt.21/06/2018.
