
OFFICE ORDER NO- 043 /2019.

Consequent upon Sanction of the General Manager for appointment of Substitute Control & Disaster Management Helper as a "Fresh Face" CDMH in Level-1(GP-1800) communicated vide Chairman RRC/Wadibunder letter No.P/CR/HQ/G.Admn/RRC/120/10/CDMH/SWG dated 09.01.2020 Shri. Prasad Bajarang Sajjan S/o Shri.Bajarang Hanmantu Sajjan is appointed as Fresh Face Substitute Control & Disaster Management Helper in GP-1800/- (Level-1) attached to Shri. Sachin Wamanrao Ganer, Sr. DEN(N)/ SUR against vacancy.

Shri. Prasad Bajarang Sajjan has passed the requisite Medical Examination in Med. Class C-I & below with spectacles vide ACMS/SUR's Medical Certificate No.450466 dated 18.01.2020 and his appointment as Substitute Control & Disaster Management Helper is subject to the following conditions-

- 1) His services are purely temporary and liable to be terminated at any time without assigning any reasons.
- 2) He will be granted temporary status on completion of 4 months of regular service. His services for grant of annual increment shall be counted from the date of his attainment of Temporary status, in terms of instructions contained in Rly.Board's letter No.E(NG)II/2006/SB/8 dated 25.07.2006.
- 3) Completion of one year service will be calculated as per instructions issued vide PCPO's letter No HPB/581/R/Circular/Rect.-39 dated 12.12.2013.
- 4) Completion of three years service will be calculated as per instructions issued vide PCPO's letter No HPB/581/R/Circular/Rect.-39 dated 12.12.2013.
- 5) The lien of Shri. Prasad Bajarang Sajjan S/o Shri.Bajarang Hanmantu Sajjan will be fixed as per medical fitness at the time of regularization after completion of 3 years service.
- 6) He will be terminated with immediate effect, if he has not completed one year, when the officer to whom he is attached with does not take him along with on transfer to another Railway/Unit as per instructions issued vide PCPO's letter No. HPB/581/R/120 dated 20.06.2018.
- 7) He will be treated as UR subject to verification of SC Caste Certificate.
