All the promoted employees are eligible to exercise an option within a period of one month for fixation of pay. The date of shouldering higher responsibilities along with option for fixation of pay, if eligible, should be forwarded to this office immediately for timely fixation of pay. All promotions shall be subject to outcome of the main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)1125/8 dated 30/09/2016 (RBE No.117/2016) and as per instructions of HQ letter No.P/HQ/ Rulinf/O/817 dt.04/10/2016 and clarification of HQ's letter No.P/CR/HQ/RP/601-Policy dt.15/03/2017 and in terms of Railway Boards letter No.2018-E(SCT)/25/9 dt.19/06/2018 circulated by CPO/CSMT vide letter No.P/HQ/Ruling/O/817 dt.21/06/2018.
