

However, those who have financially upgraded against MACP scheme are not eligible for fixation of pay on regular promotion as per annexure para 4 of Railway Board's letter No. PC-V/2009/ACP/2 dated 10.06.2009. The date of shouldering higher responsibilities of the employees should be advised to all concerned without fail.
