

The above posting / promotion order is provisional and subject to the condition that there is no DAR/SPE/Vig case pending against them and they are not undergoing any penalty debarring promotion which should be ensured by the supervisor / official concerned before the promotion is affected. The promotion is also subject to disposal of Writ Petitions/appeals/applications pending in Honorable Supreme Court/High Court or CAT as the case may in occupation before carrying out the transfer/promotion order.

The employees may exercise option for fixation of pay in the promoted grade within one month from the date of promotion in terms of Railway Board's letter No. E(P&A)11/81/PP dated 13.11.1981 and option once exercised will be final. However, those who have financially upgraded against MACP scheme are not eligible for fixation of pay on regular promotion as per annexure para 4 of Railway Board's letter No. PC-V/2009/ACP/2 dated 10.06.2009. The date of shouldering higher responsibilities of the employees should be advised to all concerned without fail.
