The above named candidate is nominated for field training under SSE/Sig./SUR. till further instructions.


He has fulfilled the following conditions and directed for training.

- 4) Executed Agreement Bond on the prescribed form to serve for a period of 05 years in the Railway Administration faithfully and efficiently. In case he is leaving the Job/ Appointment, he has to refund the stipend plus training cost and 12.1/2% P.A interest thereon.
