- Further to RRC/CR's letter of even number dated 18.12.2019 and 20.02.2020, provisional eligibility list of candidates is available on RRC/CR's website www.rccr.com
- It may be noted that candidature of all eligible candidates shall be purely provisional at all stages of selection subject to fulfilment of all the eligibility conditions. If it is found that any candidate has furnished incorrect/false information, RRC/CR reserves the right to cancel the candidature of such candidate at any stage of selection procedure and decision of RRC/CR in this regard shall be final and binding on all the candidates.
- In case any candidate has any genuine objection, he/she can make a representation with copy of downloaded application with relevant details and supporting documents. Concerned office will forward only those applications to RRC/CR with their remarks, which are found genuine. All the Eligible / Provisionally Eligible / Not Eligible candidates have been personally intimated through email and SMS.
- There were also complaints from some employees that their names were not appearing in the list given to Units for scrutiny. Hence, such employees may be advised to submit the copy of representation along with copy of online application with documents uploaded to their depot for scrutiny by 05.10.2020, if already registered online.
