The financial up gradation under MACP Scheme is awarded to the under mentioned employee with effect from the date shown against their names.



Financial up-gradation under the MACPS shall be purely personal to the employee and shall have no relevance to his seniority position. This Office order is subject to condition that employees are not undergoing any effective punishment under DAR, VIG and SPE Cases etc.
