
Sub: Rationalisation of flexi fare scheme in Rajdhani, Shatabdi and Duronto trains.

In partial modification of above instructions, Ministry of Railways have decided to delegate power to PCCMs of Zonal Railways to implement graded discount scheme in Rajdhani, Shatabdi & Duronto trains from 01 day to 04 days prior to scheduled departure of train i.e (D-1 to D-4) instead of the existing D-4 (04 days) prior to scheduled departure of the train.

2. There shall be no change in others terms & conditions.


