1)The MACPs envisages,merely placement in the immediate next higher grade pay in the hierachy of the recommended revised pay bands and grade pay as given in section 1,Part-A of the first schedule of the Railway Service (revised Pay)rules-2008.

2)With regard to fixation of pay on grant of promotion/financial up-gradation under MACPs,a Railway servant has an option under rule 1313(1) a (i) of Indian Railway Establishment Code-Volume II (6th Edn. 1987-2nd reprint-2005).

3)On the grant of financial up gradation under the scheme, there shall be no change in the designation , classification or higher status.

4)Financial upgradation under the MACPs shall be purely, personal to the employee and shall have no relevance to his seniority position.
