The following candidates recruited through RRB against CEN No 01/2018 for the post of App. ALP on Stipend Rs 19900+ DA as admissible time to time in Pay Matrix Level 2 vide Dy CPO(NG) CSMT's letter quoted under reference. On completion of all recruitment formalities, they have been offered appointment as App. Tr. ALP on usual terms and conditions.

As per ZRTI/BSL's letter dated 03/09/2020, competent authority has approved to conduct training for Initial ALPs as far as possible in online and classrooms in 3 phases, partly in ZRTI and partly in the respective divisions. Total duration of training of ALPs is 109 working days. First phase 35 days at ZRTI, Second phase 35 days at division, Third phase 29 days at ZRTI and last phase 10 days in the division. They are directed for initial training in the fourth batch commencing from 23/12/2020 to 03/02/2021 at ZRTI/BSL.

They have fulfilled the following conditions and directed for initial training.

- 1) Accepted offer of appointment on the conditions mentioned in the Agreement Bond
- 2) Passed medical examination in prescribed medical class required for the post of ALP
- 3) Administered Oath of allegiance.
- 4) Executed agreement bond in the prescribed form to serve for a period of 05 years in the Railway Administration faithfully and efficiently. In case they are leaving the job/ appointment, he has to refund the stipend plus training cost and 12.1/2% P. A. interest thereon.

They will be governed by New Pension Scheme in terms of RB's letter No F(E) 2003/PNI/24 dated 31/12/2003 and 2002/AC II/21.1 dated 27/02/2004 to contribute 10% of his Pay + Dearness Allowance for the New Defined contributory scheme. On resuming / reporting training they will be paid stipend @ Rs 19900+ DA as admissible time to time.

They will report at ZRTI/BSL on 22/12/2020
