The Greenfield PFT (PCPK) of M/s. CONCOR at Mihan served by Khapri station on Nagpur Division was temporarily is re-opened for outward container and bagged commodities and inward for all commodities on temporary basis for a period of 06 (six) months i.e. upto 12.03.2020 vide ARN referred to above at Sr.No 02 and extended further from time to time through commercial control message, presently valid upto 15/07/2020.

Now, with immediate effect it has been decided by competent authority to open this PFT on permanent basis to deal limited outward traffic of containers and bagged commodities and inward traffic of all commodities till installation of EIMWB.

Railway Receipt will be prepared as per weighment sheet of Road weighbridge (Weight certified by customs) and undercharges, if any, detected will be collected at destination (as per ACDA, Ajni pattern). Division to ensure weighment of rakes as per Rates Master Circular /Weighment/2019/0 dated 25/07/2019

All the other terms and conditions notified shall remain un-changed.
