- 3) Administered Oath of allegiance.
- 4) Executed Agreement Bond on the prescribed form to serve for a period of 05 years in the Railway Administration faithfully and efficiently. In case he is leaving the Job/Appointment, he has to refund the stipend plus training cost and 12.1/2% P.A interest thereon.
- 5) As per School leaving Certificate No.1467(Reg No.13397) issued by Sholapur Social Association Urdu High School, Solapur, Dist- Solapur, his Date of Birth is 17/09/1992.

He will be governed by New Pension Scheme in terms of Rly Bd's Letter No. F(E) 2003/PNI/24/dated 31/12/03 & 2002/AC II/21.1 dated 27/02/2004 to contribute 10% of his pay + dearness allowance for the New Defined contributory scheme.
On resuming/reporting training he will be paid stipend @ Rs. 35400/-.
