Shri. Vilas Ramarao Upadhye, Goods Guard /SUR had been issued the Penalty of " Withholding of Increment for two years (NC) vide Sr. DOM/SUR's letter No.U/T/Coaching/DAR/Acci/17/2018 dated 03.01.2019 i.e. the annual increment due on 01.01.2020 was withheld for 02 years, up to 31.12.2021 (NC).

Further on appeal ADRM/SUR vide letter No. U/T/Coaching/DAR/Acci/17/2018 dated 11.03.2020, had reduced the penalty to " withholding of increment for a period of One (01) year (NC), i.e. up to 31.12.2020.

Now above named has completed his penalty on 31.12.2020.


Above named is not eligible for any facility on transfer account.

However if above named has already awarded higher grade under MACP scheme is not entitled for pay fixation on his regular promotion as it is the same grade granted under MACP in reference to Para 4 of Annexure of Railway Board's letter No.PC-5/2009/ACP/2 dated 10.06.2009. Option once exercised shall be final.

It is the responsibility of controlling supervisor to inform the concerned staff accordingly. The date of shouldering higher responsibilities of the employee should be advised to all concerned without fail.

The promotion is also subject to disposal of Writ Petitions/appeals/applications pending in Honorable Supreme Court/High Court or various CATs as the case may in occupation before carrying out the transfer/promotion order.
